Course Overview

Start a purposeful career working with children and ensure their safety, well-being and development goals are achieved. Students will learn how to use organisational policies, procedures and individual children's profiles to plan activities and provide care to children; facilitating their leisure and play and enabling them to achieve their developmental outcomes in an inclusive way.

Job outcomes include; educator, recreation assistant, playgroup supervisor, kindergarten assistant.

Duration, Delivery & Assessment

- 12 months (average)
- 32 face-to-face sessions - 1 x 5 hours class per week
- Assessments include; written & oral questions, projects and observations of skills
- Recommended 16 hours of self-paced learning per week
- 120 hours of work placement at a regulated education and care service



Location

Our main campus is at 39/617-643 Spencer Street, West Melbourne. We try to group students from the same location together and hire out venues that are closer to home. The exact location of classes will be confirmed once you talk to a representative of Melbourne College of Further Education

Pathways

On completion of this qualification you may wish to undertake the CHC50113 Diploma of Early Childhood Education and Care.



Entry Requirements

- The ability to travel to and from placements - placement hours can be early starts
- Access to a computer or smart device and the internet to complete your studies.
- Obtain a Working with Children check (WWCC) prior to commencing your placement
- The required Language, Literacy and Numeracy skills to complete a Certificate III level course. This will be assessed in your pre-training review during enrolment.

Fees

This training is delivered with Victorian and Commonwealth Government funding. The course fees depend upon eligibility for a Government subsidy, via the Skills First Funding Program.
